BOARD ORDER

Under the authority of section 56(4) of the *Workers' Compensation Act*, the Board of Directors orders that for 2015 maximum insurable earnings be increased to \$95,300, representing a 3.3% increase over the 2014 maximum insurable earnings of \$90,200.
